



## Stock donations

Thank you for your interest in donating stock to the National Inventors Hall of Fame. The tax planning benefits of donating appreciated shares of stock include deducting the amount of the charitable donation *and* avoiding the unrealized gains on the appreciated shares. Prior to donation, please seek advice from a qualified tax professional on how this may affect your tax situation.

Following are a few simple steps to complete your donation:

1. Contact your financial institution, let them know you would like to gift stock, and ask for the appropriate form to fill out in order to do this. You will likely need to have the following information handy to provide to your firm:
  - Your account number
  - The quantity of shares you would like to gift
  - The description of the shares (i.e., Google stock)
  - CUSIP/Symbol number of the stock (you can access this from your account statement, or <http://finance.yahoo.com>)
2. You will need to provide your firm the following information about us, as well:
