

Camp Ambassador Campaign – Terms and Conditions

Effective Date: 3/5/26

Sponsor: National Inventors Hall of Fame (“Sponsor”)

By participating in the Camp Ambassador Campaign (“Campaign”), participants agree to be bound by these Terms and Conditions.

1. Campaign Overview

The Camp Ambassador Campaign is designed to reward Camp Ambassadors who promote Camp Invention programs using Camp Ambassador–exclusive promotional codes. Eligible participants may earn a \$250 Amazon gift card if their Camp Invention Program has the most campers signed up using a Camp Ambassador promotional code.

2. Campaign Period

The Campaign runs during the Camp season from May 26 through August 17 (“Campaign Period”).

3. Eligibility

To be eligible to participate in the Campaign, an individual must:

- Be approved and registered as a Camp Ambassador;
- Be at least 18 years of age at the time of participation;
- Be associated with an eligible Camp Invention program operating during the Campaign Period; and
- Comply with all Campaign requirements and these Terms and Conditions.

Sponsor reserves the right to verify eligibility and disqualify any participant who does not meet these requirements.

4. How to Participate

Participation in the Campaign requires completion of the following steps:

Step 1: Sign up to be a Camp Ambassador through the designated registration process.

Step 2: Complete all required items listed on the **Camp Ambassador Checklist**.

Step 3: Submit a picture of the completed Camp Ambassador Checklist via email to communications@invent.org by the first day of your Camp Invention program’s start date.

Failure to complete or submit any required step may result in disqualification from Campaign eligibility.

5. Weekly Award Structure

- Each week during the Campaign Period, Sponsor will identify all Camp Invention programs operating that week.
- Among those programs, the Camp Ambassador whose Camp Invention program generates the highest number of camper registrations using a Camp Ambassador promotional code will be designated the weekly winner.
- The weekly winner will receive one (1) \$250 Amazon gift card.

Only one weekly award will be issued per eligible Camp Invention program per week.

6. Promo Code Tracking

- Each Camp Ambassador will be provided with promotional codes unique to the Camp Ambassador community.
 - Only camper registrations completed using the Camp Ambassador promotional codes and confirmed by Sponsor's registration system will count toward weekly totals.
 - Sponsor's tracking and reporting systems will be the sole and final authority for determining registration counts and weekly winners.

7. Prize Conditions

- Prizes are non-transferable and may not be substituted or redeemed for cash.
 - Sponsor reserves the right to substitute a prize of equal or greater value if the stated prize becomes unavailable.
 - All federal, state, and local taxes associated with receipt or use of the prize are the sole responsibility of the winner.

8. Notification and Delivery

Weekly winners will be notified using the contact information provided during Camp Ambassador registration. Gift cards will be delivered electronically or by another method determined by Sponsor.

Failure to respond to a prize notification within the timeframe specified by Sponsor may result in forfeiture of the prize.

9. Conduct and Disqualification

Participants must:

- Act in a professional and ethical manner;
- Follow all Camp Ambassador guidelines and brand standards; and
- Avoid misleading, deceptive, or inappropriate promotional practices.

Sponsor reserves the right to disqualify any participant who violates these Terms and Conditions, engages in misconduct, or attempts to manipulate registrations or results.

10. Sponsor's Rights and Discretion

Sponsor reserves the right to:

- Modify, suspend, or terminate the Campaign at any time for any reason;
 - Interpret and apply these Terms and Conditions in its sole discretion; and
 - Make final and binding decisions regarding eligibility, registration counts, and prize awards.

11. Limitation of Liability

To the fullest extent permitted by law, Sponsor shall not be liable for any indirect, incidental, or consequential damages arising out of or related to participation in the Campaign or acceptance or use of any prize.

12. Governing Law

The Campaign and these Terms and Conditions shall be governed by and construed in accordance with the laws of the state of Ohio, without regard to conflict of law principles.

13. Acceptance of Terms

Participation in the Camp Ambassador Campaign constitutes full and unconditional acceptance of these Terms and Conditions.
